

- Governor Nikki Haley (R, incumbent) & Vincent Sheheen (D) are unopposed in the primaries.
- Lt. Governor Glenn McConnell (R, incumbent, retiring in 2014). Candidates include Mike Campbell (R) Business Consultant and son of Ex-Governor Carroll Campbell; Pat McKinney (R) Businessman, Ex-State Port Authority Member, Ex-State Education Board Member; Henry McMaster (R) Ex-Attorney General, Ex-State GOP Chairman, Ex-US Attorney; Ray Moore (R) Minister, Retired Army Officer, Gulf War Veteran, GOP Activist. Bakari Sellers (D) is unopposed in the primary.
- S.C. Comptroller General- Richard Eckstrom (R, incumbent) against Robert Shelley (R). Kyle Herbert (D) is unopposed.
- S.C. Superintendent of Education- Mick Zais (R, incumbent, retiring in 2014). 

### Fire Department

Chappells Fire and Rescue is under stress these days. Constrained County Funding and a fall in the number of volunteers are beginning to threaten public safety in this district. In addition to the obvious life threatening dangers caused by inadequate response to emergencies there are also related issues of property value and insurance rates.

The recent experience of one Summerset/Windmill resident during a serious medical emergency highlights what may become a persistent problem in our community. In an open letter by Cort Nagle, President of the POA, (see January issue of The Heron) Cort detailed the delays and obstacles preventing timely treatment for that resident.

Chief Engemann told The Heron that the fire siren has been out of service for a year. In this digital age the siren may not be as relevant as in the past. However, in addition to fire

alarms, sirens also serve to alert the community in case of tornado threats. That department sirens are tested each week speaks to their utility. The need is for a new tower and siren. The county wants to simultaneously install both items. Is the delay a county budget issue? In addition the county has delayed other funding items including the installation of a backup generator.

The other major crisis is the lack of volunteers. The demographics of this community do not lend themselves to resolving the need for firefighters and EMS Technicians. In attempting to recruit volunteers Chief Engemann indicates there are many ways to help other than fighting fires. Volunteers can direct traffic, do administrative functions; assist with fundraising, drive vehicles etc. Ultimately, the county may need to face the issue of paid firefighters.
