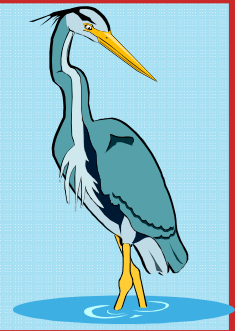

Cheaper Gas

HURRAY!! Gas prices at the pump have dropped and you have more money in your pocket. But there are those in government who think you don't deserve this "windfall". This is a newly found bucket of money that government covets as their own and you can keep just what the politicians will allow.

This last issue of The Heron raised the specter of a state fuel tax increase when the legislature came back in session. They are now in session. Stalking horses for the state legislature have been pressing hard for business and transportation advocates to make the argument that South Carolina needs more money for roads and bridges. They assert that poor roads cause drivers to pay \$1,150 a year for car maintenance, fuel consumption and fatal crashes. This seems to be an indictment of how DOT is currently maintaining roads. What assurance is there that DOT will do better with more money?

The additional argument is that the South Carolina Gas Tax hasn't been raised in thirty years. Where does it say taxes should be raised just because they have not been raised over a given period of time?

Poor roads are a problem and do add to the cost of driving. The question is whether more money is the solution. Are you confident that the current fuel tax revenue is being spent wisely?

And now the federal government is also trying to grab some of your new found "wealth". For once this is a bipartisan effort. In addition to the Democrats, "big government" Republicans have joined the chorus to raise the federal fuel tax. These include Bob Corker, James Inhofe, Orrin Hatch, and John Thune. These Senators have been identified by cable news networks as being in support of increasing the gas tax.

Again, the question remains whether you believe your tax dollars are being spent wisely. The CBO reports that up to thirty percent of fuel tax revenue goes to other than roads and bridges. For example, last year, Five Billion Dollars was spent on mass transportation, Eight Hundred Million was spent on walkways and bike trails, and Sixteen Million was spent on transportation museums. These may be worthy projects or just typical pork barrel corruption. In either case when the driving public is asked to pay taxes for roads and bridges, the revenue should go to roads and bridges.

Basic economics tells us that prices are low because the global market is flooded with oil. It also tells us that oil companies will react by reducing supply until prices rebound. Do you believe that state and federal increases in the gas tax will then be rescinded?

By the way, the Obama Administration had a lot of trouble finding "shovel ready" road projects and so redistributed "Stimulus" money to favored campaign supporters.

Thank you to the person(s) who annually decorate our entrance stonework with beautiful Christmas decorations.

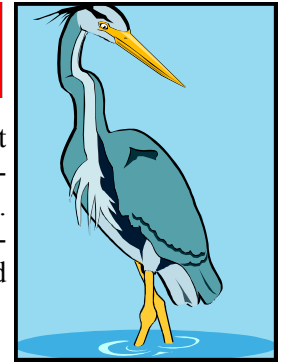
Welcome to new readers *By the editor*

POA Board News

The Summerset/Windmill POA is peculiar among similar organizations in that membership is voluntary. Surprisingly over the years the association has managed to maintain an average 70% membership. Many of the non-members are lot owners who may be holding their property as an investment or have no immediate plans to build. There are a few others who for their own reasons chose not to participate. The relatively high participation rate suggests that the POA must be doing something right.

If you have not already renewed your membership in the POA, now is the time to do it. At this point in time about fifty percent of property owners have renewed for 2015. Past history tells us that it is not unusual for a relatively large number of members to wait until after the holidays to send in their dues. Membership renewal is just \$100 and most would agree it is a very reasonable regime fee. If you were not a member last year and you wish to join, there is a membership form on the last page of this newsletter.

For your membership you get a community where landscaping and mowing improve the appearance of the neighborhood. You also get to have chance to join with others in voicing concerns with local government.

At the general meeting in April, membership will have a chance to vote for two board members. The membership elects the board members and the board then appoints the officers. Everyone is encouraged to submit names, including your own, for nomination to the board. Last year we lost board director Cort Nagle. He will be hard to replace since the board had appointed him President. Nomination forms will be sent in the March issue of The Heron.

- ◆ The Summerset/Windmill residents owe a debt of gratitude to Roy Mendelsohn and his band of volunteers who for many years now have seen to the tailored look of our roadsides. Roy himself mows and organizes the schedule of mowing. He and his team maintain the equipment and have now serviced it for the winter. Roy reports that the mower is five years old and has 500 miles of operation. It may be time for

a new mower. Roy will collect comparative information on mowers and report back to the board. The board voted to delay any decision until the March Board Meeting.

- ◆ Jim Smith leads a team that works on enhancing the landscape in the neighborhood. One big problem they have been working on is control of erosion in several areas. With a consult from Clemson Extension, they have experimented with several varieties of grasses. In some places they used rip-rap. An important part of this effort is to make it safer and easier to mow. You have probably noted another team project, dressing up entrance areas with crape-myrtles.
- ◆ Lou Rosenthal of the Architectural Committee noted a number of new homes either recently built or under construction. The most recent start was site preparation on Lot 4 of Summerset Bay.

All the men in the neighborhood including Summerset Bay, Waters Edge, and other surrounding communities are welcome to join us.

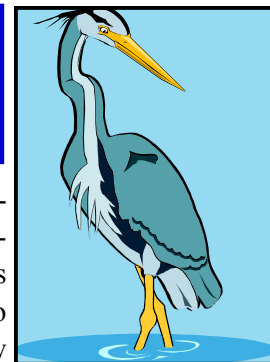
We indulge in a good breakfast, congenial conversation and tall stories.

Fire, Rescue and Medical Emergency Services Chappells residents have a continuing concern about Emergency Medical Response. We've been told that Newberry County Emergency Management has entered into an agreement with Laurens County for mutual aid to cover when a timely response to Chappells medical emergencies is otherwise not possible. Also, The Heron is informed that a new EMT candidate, Larry Watson, will take the examination this month. These are incremental improvements. Are they sufficient to make you feel your emergency needs will be met?

Years have passed since the Chappells Fire and Rescue began work on a fireboat. One of the impediments has been the failure of Newberry County to fund a pump. At this point Tommy Long, Newberry County Emergency Management, reports that he and the Chappells fire officials are looking to use the boat for rescue operations only. They assert that current levels of manpower would limit the ability to operate the boat as a water supply. However, they still don't have funding to even make it a rescue boat.

Mike Engemann reports that the fire department will have a fundraiser, fish fry, this March or April.
