Medical Emergencies

Chappells Rescue and Emergency Medical Services have fallen on difficult times. At just three miles from our community, EMS is well positioned to serve this neighborhood. This station is fully equipped with a rescue truck and an ambulance. However, it is seriously handicapped by a lack of staff. Solely dependent on volunteers, the ability to respond has been hampered by the lack of members and member training. What should be a fifteen to twenty minute response time has stretched to a forty-five to

ninety minute arrival at the scene of an emergency. The residents in this area are primarily senior citizens subject to the risks that come from advancing years. It is common knowledge that heart attacks, strokes and other medical incidents are at reduced rates of successful treatment with delayed reaction.

Wayne Trotter and his wife Ann had need of these services on two occasions, first in November of 2013 and again in May of 2014. It all began on November 4, 2013, when Ann Trotter had a stroke. Mr. Trotter's experience with Newberry County Emergency Services has alarmed everyone in this area. In an interview with The Heron, Mr. Trotter related his interactions with the 911 dispatcher and the resulting anxiety in getting help for his wife. (cont'd Page 4)



Government Services

There are in excess of one hundred taxable real estate properties in this neighborhood in addition to all the taxable personal properties, i.e., cars, boats, personal watercraft and recreational vehicles. As a community, comprised mostly of retirees, the taxpayers in the Summerset/Windmill developments look to state and local government for two basic services. They are public safety and road maintenance. These services have fallen dangerously short of expectations.

County Line Road

County Line Road is the principle access road to Summerset Bay, Summerset Point, and Windmill Landing Developments. Pineland Road is the only other road that leads into our area. Pineland Rd. is a winding road that enters the lakefront from the South end and is primarily used by the WatersEdge community. Of note, Pineland Road has recently been repaved.

County Line Road, on the other hand, is in very bad condition. As

the name suggests this road is partly in Laurens County and partly in Newberry County. Solutions to fix this road seem to be buried in a bureaucratic morass among several entities including the state, and the two counties.

The Newberry County portion alone has been frequently patched and the patches have been patched and then potholes have developed in the patches of the patches. Of course, the patches do not hold up as well as the original paving. Gradually the original pavement is disappearing under a surface of patches. (See photos below.)

- 6) Cell Phone optional for emergencies.
- 7) Paddles in case your engine quits?
- 8) Situational "awareness" during peak boating traffic on the weekends.
- 9) Observe "no wake" speed limits close to docks
- 10) Water skiing or tubing spotters are necessary in the boat.


Communication – Ceil Mescall handles Email notices on current issues. She will update the website with recent Herons.



Medical Emergencies (cont'd)

Wayne Trotter is not one of our retirees. He is still employed and at 6:45AM of November 4 he was on a conference call from his home when he heard

his wife in the bathroom. She was mumbling repeatedly "head hurt", "head hurt". He went to investigate and found his wife almost unconscious and face down in vomit on the floor. He immediately

called 911 and reached a Newberry dispatcher who inquired about the situation and said that help was on the way. After twenty minutes Mr. Trotter called again and was assured that a team was "on the way" but they did not have further status. After another fifteen to twenty minutes he was told that the EMS team was in Silverstreet (sixteen miles away). When two people finally arrived they blamed the delay on bad timing, a "shift change". They transported Mrs. Trotter to Self Memorial Hospital where she was diagnosed as terminal. However, in a valiant attempt to save her life, she was airlifted to Charleston for neurosurgery. Against all odds, Mrs. Trotter survived her stroke.



On May 28, 2014 Mrs. Trotter again exhibited signs of a stroke, drooping of the left side of her face. Unwilling to rely on a quick EMS response, Mr. Trotter called 911 and told them that he was starting out for the hospital in his personal vehicle and would like EMS to intercept him in transit so they could administer any possible emergency medical aid. After what Wayne Trotter considered a series of unhelpful queries, he did manage to meet Cross Hill EMS as he drove through the town of Cross Hill. Cross Hill EMS then took over and transported his wife to the hospital.

Mrs. Trotter survives to this day but is totally dependent on her husband for all life activities. Would a quicker EMS response last November have improved her present quality of life? It's impossible to tell but something needs to be done about EMS services in this area. Mr. Trotter and the Summerset/Windmill POA are seeking solutions to the problem.
