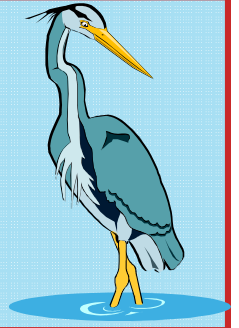

## Emergency Medical Service

Emergency Medical Service, EMS, is now fully functioning. The Chappells ambulance is up and running. However, there is only one trained Emergency Medical Technician, EMT. **More volunteers are needed.** Our community tends to be retirees, many in advancing years, and so more likely to be users of EMS than volunteer providers. However, even if you can be a driver to accompany the EMT on an emergency response, you can fill an important role.

Local EMS consists of basic care and transport. The EMT is capable of doing vital life measurements and is trained to use a defibrillator, AED. The ambulance can transport a patient to Greenwood if Self Memorial is identified as the hospital with which the patient's doctor is associated. All members of the Chappells Fire and Rescue Team are CPR certified and do accompany the EMT on calls.

There is also a paramedic always on call for Advanced Life Support. A significant problem is that Advanced Life Support comes through the county and is dispatched to Chappells from Silverstreet and beyond. There is a "mutual aid agreement" with Laurens County, Cross Hill, to respond as needed.

## EDITOR'S NOTE

It must be stated that there is a very low confidence level among residents of this community that EMS response, either basic or advanced, will be timely and effective in spite of current arrangements. An incident involving the wife of one of our members who suffered a very delayed and ineffective response lends credence to this concern. The most commonly heard statement is "we pay a very high property tax and get very little for it".

## Be Prepared

We are obviously a community of mostly senior citizens. Whether a senior or not, whether you have a spouse or live alone, it pays to be prepared for an emergency medical situation. A first responder needs basic medical information about you. In an emergency situation you may or may not be able to communicate. This data is valuable to have at hand at home but also on your person if you are away from home.

You need to document:

- ◆ Current medical status, e.g., diabetic, pacemaker, etc.
- ◆ All current medications. (Meds change and you need to continually update this information.)
- ◆ Allergies, especially drug allergies.
- ◆ Emergency Contact(s)
- ◆ Primary Care Physician
- ◆ Hospital with which your doctor is associated.
- ◆ Healthcare Directive. (DNR, Do Not resuscitate, signed by your doctor if applicable.)

One way to document this data is to join the "Vial of Life" program, [vialoflife.com](http://vialoflife.com). The program and materials are **FREE**. You can begin with the form included in this newsletter. (page 4) If you go on-line with this program you can also get a kit that includes a decal for your front door that alerts a first responder to check your refrigerator. The package also includes a baggie and magnet to attach to the door of your refrigerator.

**Don't forget to carry the enclosed form or other similar documentation on your person when you are traveling or just out and about.**

## Buzzards Roost Dam

Over the years, Mr. Roy Mendelsohn has carefully and persistently monitored Greenwood County, The Federal Energy Commission, (FERC) and The Department of Natural Resources (DNR) policies and procedures regarding anything affecting Lake Greenwood. It was largely due to his efforts that the "rule curve", i.e., policy on winter draw-down, has been modified to give fuller use of the lake.

In response to a mandate from FERC, Greenwood County has created a fund to upgrade and strengthen Buzzards Roost Dam. Are these monies still needed and, if not, how should they be redirected?

Recently, Hurricane Joaquin came through South Carolina dumping vast quantities of rain across the state. A good deal of the resultant flooding could be attributed to the failure of many of the dams throughout the state. Apparently Buzzards Roost Dam at the South End of Lake Greenwood held fast and served its function well.

## County Line Road

The condition of County Line Road has been a source of consternation in Summerset Bay for many years. At times the road has taken on the appearance of a back road in a war zone. It seems that help may be on the way.

Senator Ronnie Cromer responded to an article in the last issue of The Heron. Immediately the worst potholes were patched making the road less jarring to drive. However, we all know that the patches are an interim solution at best. Already there are signs that the patches are starting to break up and we have still to go through a winter season.

The good news is that Senator Cromer is working to get County Line Road resurfaced by the end of the fiscal year, i.e., mid-summer 2016. He has assured us that he is working with Newberry and Laurens Counties as well as the South Carolina Department of Transportation.

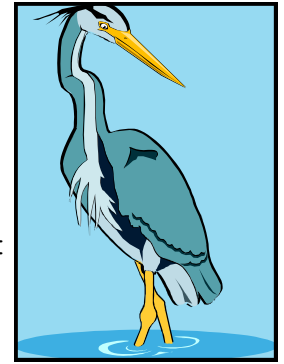

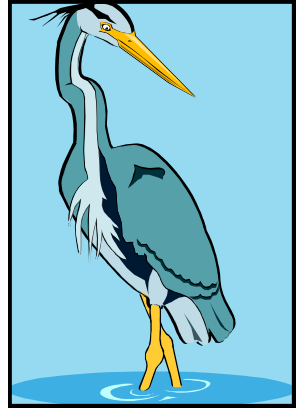

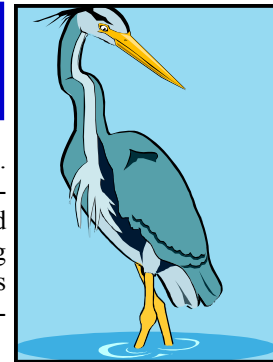

## Chappells Fire Department

Hurricane Joaquin hit South Carolina with a destructive force. Much of the Low County and Midlands suffered with significant flooding. The whole state received excessive rainfall and

winds. Although there was no serious flooding in the Chappells area, there were many fallen trees impeding travel on all of its roads. The Chappells Fire and Rescue team spent in excess of twenty continuous hours with chain saws clearing Routes 56, 39 and 34. They also worked to clear residential roads including Pine-land Road and Summerset Bay Roads.

Volunteers in the Chappells Fire and Rescue Department are receiving training on Inmate Supervision. Detainees could prove to be a ready source of labor to do many time consuming tasks such as washing trucks and grounds keeping thus freeing up volunteers to work on necessary fire and rescue skills.

The recent chicken dinner fundraiser was a success. Deductible donations are always welcome and may fit into your "end of year" tax planning. Donations do not always have to be cash. Consider donating cases of bottled water or replacement flagpole flags.
