News from the Board

Board President, Cate Carpenter, recently attended meetings related to the Conestee Dam and the Lake Greenwood Master Plan

Lake Greenwood Master Plan

At the last meeting on March 7, a lot of information was shared. Copies of presentation slides will be shared at our annual meeting. A couple of takeaway points:

- Development around Lake Greenwood is slowing. There are only about 300-350 waterfront lots available for home construction.
- We do not have the numbers on our side of the lake for a grocery store on our side of the lake. People want more dining opportunities than a grocery store.
- Sewer system/septic tanks appear to be an environmental issue in some areas; however, there are not many records of what has gone on in the past so difficult to assess what needs to be done.
- Sediment in the lake is also a concern but it is not the scope of this initiative to evaluate the sediment depth of the lake. They will recommend that this is undertaken by another appropriate organization.

Conestee Dam Update

The Lake Conestee Dam Restoration Project (LCDRP) is on track and under budget. It is believed that the dam will be finished in September 2026. Bidding has been narrowed to 4 companies and the bids are due towards the end of March. It will then take 2 weeks for evaluation and a decision on which bid will win. The new dam will be built in front of the current dam and cannot disturb the sediment behind the old dam. Neighborhood Updates

The goal of the Board is to support keeping our neighborhood beautiful!

- Trailers: The Board is aware that this is a topic that concerns many members of the POA. The Board did obtain a ruling from the Newberry County attorney which states that trailers (RV's and travel trailers) cannot be visible. Most recently, there were two trailers in violation of this ruling. One has now been enclosed so is no longer visible. The Board is in communication with Newberry County regarding the other trailer.
- Neighborhood signs and surrounding landscaping: Two of the four neighborhood signs have been replaced. The other two will be cleaned and refreshed over the coming months. The Board has also approved the purchase of some evergreen trees to be planted around the some of the signs.
- Culverts: There is significant concern about the integrity of the culvert at the intersection of Summerset Bay Drive and Road. The Board is communicating in writing to the Newberry Dept. of Public Works to have this addressed.
